1. To be eligible, you must:

- **Not** be a citizen of **France or Canada**. Priority will be given to applicants from member countries of the Francophonie (excluding France and its overseas departments and territories - DOM-TOM), and countries of the leading markets of Asia (China, India, Japan) and the Americas (Mexico, Brazil);
- **Not** have Canadian citizenship or a Canadian permanent resident status or be in the process of obtaining the permanent residence status under the Canadian immigration laws;
- Be outside of Canada at the time of submitting your application and until the announcement of results;
- **Not** be less than 18 years of age. There is no maximum age limit;
- **Not** have been a beneficiary of a scholarship for studies of the same level or higher than the DVS in Quebec. In addition, being awarded various scholarships within the same academic year is not allowed;
- Have the required financial capacity.

2. Eligible training programs:

The current competition regards the vocational training programs that commences on August **2021**.

The award programs are only open to [vocational training programs](#), short courses that focus on learning skills directly related to the job market. These award programs DON'T apply to college or university programs.

3. To register:

PLEASE NOTE: Multiple applications will be automatically rejected. Candidates must submit their applications by themselves, even if they are helped by a relative. In any case to the contrary, please note that your application could be refused. No request made by an agent will be accepted.

The application process is **free**.

PROCEDURE: Starting from July 13, 2020

- **Eligibility:** Find out if you are eligible to participate in the process (see criteria here);
- **Choice of training program:** Choose your training program and training centre from the list provided (only **ONE** choice is possible).
- **Choice of award program:** Choose the award program that you are applying for (Merit Scholarship **and** Exemption **OR** Merit Scholarship only).
- **Registration:** Open your online account (this section will only be available after the selection process is officially open)

Prepare your application by filling out and submitting the following documents:

***Please note that you must upload all your documents for each of your academic programs within a SINGLE electronic file. For example, your Bac diploma and your transcript must be uploaded a one document.**

**** Examples of proof of sufficient financial capacity: Original bank statement (yours or your guardian's) for the last twelve (12) months (bank book, statements) and/or bank letter indicating current balance (yours or your guardian's) and/or any proof of continuous income for the entire duration of your studies in Quebec. See Annex 2 below.**

IMPORTANT: Incomplete, illegible, or non-compliant application will be rejected. False statements or fraudulent documents will automatically result in rejection of the application and the candidate will be rejected from current and future competition.

Selection criteria:

- Academics: 40%
- Awards and distinctions: 5%
- References: 15%
- Motivation letter (relevance, motivation and quality of language): 30%
- Overall quality of application: 10%

ANNEX 2

Proof of financial capacity

Examples of proof of sufficient financial capacity:

- Original bank statement for the last twelve (12) months (bank book, statements);
- Bank letter indicating current balance;
- Bank loan: Bank letter indicating amount received and modalities;
- Any proof of continuous income for the entire duration of your studies in Quebec;
- Proof of funds transfers in a Canadian bank or to the school in Canada (in both cases, the bank or school in Canada must send an acknowledgment of receipt of the bank transfer indicating the name of the account holder and you must submit this document with your application).

If the expenses related to your study project in Quebec are undertaken by another person, this person must provide proof of financial capacity:

- The Declaration of financial support signed by the guardian;
- Proof of relationship with the guardian and/or explanation letter of implication;
- Original bank statement for the last twelve (12) months (bank book, statements) and/or bank letter indicating current balance;
- Proof of employment of the guardian (employment contract, pay slips) for the last six (6) months;
- Any other proof of your guardian's financial income.
